The project generally consists of the following work:

Contract 1 – Tank Construction - Furnishing and installing 428,000-gallon glass fused to steel water storage tank; furnishing and installing any and all appurtenances integral to the water storage tank, including, but not limited to, mixing system, lightning protection, overflow pipe, tank ladder and safety cage; coordinating with the Owner and Electrical Contractor; and record drawings.

Contract 2 – Electrical - Preparing the Site for the Work; select electrical demolition; furnishing and installing underground electrical duct banks; furnishing and installing hand-holes; furnishing and installing panelboard; furnishing and installing branch circuits; instrumentation and control circuiting; furnishing and installing light fixture, base, pole, and controls; furnishing and installing electrical boxes, fittings, and enclosures; grounding; controls and integration; furnishing and installing electrical backboard and support hardware; furnishing and installing cellular antenna; furnishing and installing tank mixing system wiring; coordinating with the Owner and Tank Contractor; and record drawings.

This work will be awarded as two (2) contracts.

Work for Contracts 1 and 2 shall be substantially completed and operational by December 14, 2018 and ready for final payment by January 15, 2019.

The Bids will be received on a lump sum basis with alternates, if included, for Contract 1 and Contract 2.

The Bids should not include sales and compensating use taxes on materials incorporated into the work.

Bids actually received by mail or by hand after the appointed time on the date specified shall be rejected, notwithstanding that such Bid may have been placed in a mail box or other mail receptacle regularly maintained by the United States Postal Service before such time, and ordinarily in sufficient time to have been delivered on time.

Bid security in the amount of 5% of the Bid must accompany each Bid in accordance with the Instruction

to Bidders.

The successful Bidder will be required to furnish a performance bond and a payment bond, each in an amount equal to 100% of the contract price.
