### RESOLUTION

Number 3 of March 11, 2019

### To Authorize Purchase of a Thermal Imaging Camera

WHEREAS, the Village of Chatham Fire Department currently utilizes two Thermal Imaging Cameras (TIC's), both of which are Mine Safety Appliances Company (MSA) Evolution 5000 series cameras; and

WHEREAS, the older camera was purchased new in 2005 and is nearing the end of its useful lifespan; and

WHEREAS, Department Chiefs and Officers have met with two independent vendors that sell and service Thermal Imaging Cameras in Columbia County: Garrison Fire & Rescue Corp., dealer for MSA and the Evolution 6000, and Municipal Emergency Services (MES), dealer for Scott and the X380 TIC; and

WHEREAS, the MSA Evolution 6000 is a similar model and the same make as the current TICs currently used by the Department and is nearly identical to the ones in service, and this model is desired due to the familiarity by firefighters and ease of training and use; and

WHEREAS, the MSA Evolution 6000 is available at a cost of seven thousand two hundred dollars (\$7,200) from Garrison Fire & Rescue Corp., which is the sole source dealer of MSA equipment in Columbia County, and the Scott X380 is available at a cost of \$8417.15, the preferred TIC is therefore also available at lower cost than the alternative;

Now, therefore, BE IT RESOLVED, that the Board of Trustees of the Village of Chatham authorizes the expenditure of funds in the amount of seven thousand two hundred dollars (\$7,200.00) from Fire Department account 1.034102.01.000.00 to purchase (1) one MSA Evolution 6000 Thermal Image Camera, from Garrison Fire & Rescue Corp., Palenville, NY, as specified in the appended quote; and

Be it further RESOLVED, that the amount of \$3,500.00 is transferred from Fire Department budget line 34104.01.000.16 (Fuel Oil) to the Fire Equipment line of 34102.01.000.00 and the amount of \$3500 is transferred from budget line 34104.01.000.23 (Vehicle Maintenance) to the Fire Equipment Line of 34102.01.000.00.

### RESOLUTION

### To authorize the purchase for DPW of a 1.5 hp 3" AMT electric diaphragm pump

WHEREAS, the Village Department of Public Works ("DPW") requires the acquisition and use of a 1.5 hp 3" electric diaphragm pump for use in the waste treatment plant; and

WHEREAS, three quotes were obtained for the desired equipment; and

WHEREAS, two vendors quoted prices of \$2,600 and \$3,272 including delivery and the lowest quote was from USA Blue Book—an online vendor—at \$1,749.95 plus delivery costs; and

WHEREAS, delivery costs will be specified by the vendor at the time an order is placed, but are expected to result the lowest net delivered cost of the three options, and the order can be cancelled if this is not the case,

Now, therefore, BE IT RESOLVED, by the Board of Trustees of the Village of Chatham, that the Board authorizes the purchase of a 1.5 hp 3" AMT electric diaphragm pump from USA Blue Book at a cost not to exceed \$2,600.00, including delivery.

### To authorize the purchase of a memorial park bench

Now, therefore, BE IT RESOLVED, by the Board of Trustees of the Village of Chatham, that the Board authorizes the purchase of a park bench at a delivered cost not to exceed eight hundred dollars (\$800.00), as shown in the quote sheet appended to this Resolution, and that such bench is to be placed in the park in the vicinity of the Gazebo.

### To authorize re-bid of DPW truck

WHEREAS, the Village of Chatham Department of Public Works ("DPW") seeks to obtain a new four-wheel drive 19,500# GVW Truck; and

WHEREAS, a prior bid process due May 24, 2018 resulted in no accepted bid, and a prior purchase effort through another municipality's bid dating from June 2018 has been repeatedly delayed and appears that it will not be fulfilled;

Now, therefore, BE IT RESOLVED, that the Board of Trustees of the Village of Chatham authorizes the solicitation of bids, pursuant to General Municipal Law section 103, for the purchase of a new four-wheel drive 19,500# GVW Truck, generally consistent with the terms and specifications of the bid specifications set out in the May 24, 2018 bid documents for a similar truck, modified as necessary by DPW and subject to review and approval by the Village attorney; and

**BE IT FURTHER RESOLVED,** that the Department of Public Works, Village attorney, and other appropriate Village officials, employees, and agents are authorized and directed to carry out such actions as are necessary to implement the purposes of this Resolution.
